### 2. DESCRIPTION ON OPERATING RESULTS AND FINANCIAL POSITION

In the first half of 2025, the global optical fibre and cable industry was under persistent market pressure. During the six months ended June 30, 2025, the Company's total revenue was approximately RMB6,384 million, representing an increase of approximately 19.37% as compared to the same period of last year; the net profit attributable to the equity shareholders of the Company was approximately RMB296 million, representing a decrease of approximately 21.69% as compared to the same period of last year; the net profit attributable to the equity shareholders of the Company after deduction of non-recurring gain and loss was approximately RMB138 million, representing an increase of approximately 15.00% as compared to the same period of last year.
